Thank you for your email. I can see that you're the contact for Florida Atlantic's existing 2013 CSD license, so if I cover anything you already know, please accept my apologies.

WebCSD forms one interface to the complete Cambridge Structural Database System comprises several locally installed software packages for expert searching and analysis of the CSD database. WebCSD provides fast access to frequently used search options.

To get institution-wide access to WebCSD you need to have a Campus licence for the CSD System.

A Campus license unlimited installation of the entire CSD System on an unlimited number of machines across a university site and in addition WebCSD access by IP range.

For 2014, the contribution for this level of access is USD 3,150.

If you would like access for three years, this would simply be three times the current contribution, or USD 9,450.

As you may know, the contribution for a Researcher license in 2014 is USD 1575.

I hope this helps, but if you have any further questions or I can be of further assistance, please do let me know.
