We typically require a 6 - 8 week lead time after placement of Purchase Order and payment of deposit is received. If payment in full is made with Purchase Order, we will advance your order in the que. Installation of the TRAZER unit requires that (8) screws be mounted in the wall. Your contractor should mount the TRAZER according to our provided template and instructions prior to the inservice.
